

Teaching Clinic Fees

All speech pathologists in the clinic are Certified Practising Speech Pathologists (CPSP), Medicare providers, and are eligible to provide services at our clinic which is an NDIS Registered Provider.

Short assessment	Assessment for one area only (eg. stuttering or speech or swallowing or reading) Fee includes 60 minute direct session, analysis and report-writing of 60 minutes. If your assessment needs more time, a fee of \$116.39/hour applies		\$232.78
Long assessment	Assessment for two or more areas (eg. Writing and speech or listening and reading) Children usually require a long assessment. Fee includes 90 minute direct session, analysis & report-writing of 120 minutes. If your assessment needs more time, an hourly fee of \$116.39/hour applies		\$407.37

Indirect clinical time	This is additional time billed for resource development, session preparation, and non face-to-face (NF2F) clinical activities. This also includes consultation with other professionals, schools, meetings, professional letters and clinical phone calls.		\$116.39/hour

Teaching Clinic Fee Conditions

Cancellations	<p>Clients must provide at least 24 hours’ notice to change or cancel an appointment or you will incur a 100% cancellation fee.</p> <p>If your session is pre-paid and you cancel within 24 hours this will be utilised as your cancellation fee.</p>
Medico-legal responsibilities	<p>Clinical records are a requirement of health services. We utilise a small amount of session time to complete the medico-legal responsibilities of your care.</p>
Payment	<p>Telehealth appointments must be paid the day prior or will be cancelled (unless otherwise agreed). All other accounts require settlement on the day of the service.</p>
Indirect Clinical Time	<p>Our team work hard to prepare resources, maintain clinical communication, and create homework for clients. All therapy sessions include 5-10 minutes indirect clinical time. If extensive indirect clinical time is required this will be invoiced separately, additional to session time.</p>
Rebates	<p>Our fees are based on the NDIS rate of \$193.99/hour.</p> <p>Teaching clinic fees are reduced by 40% (ie. \$116.39/hour).</p> <p>Fees are based on the time required for services rather than a flat rate.</p> <p>Medicare does not allow rebates to be claimed on teaching clinic services.</p> <p>This is why we have discounted the fee by 40%.</p>
Consultation with other professionals	<p>If you ask us to have additional meetings or consultations with other professionals, this will incur a fee.</p>
Appointment confirmations	<p>You may receive confirmations via text or phone call for your appointments. These are a courtesy for clients. Clients are responsible for taking note of their appointments and are encouraged to contact the clinic if confirmation has not been received. Cancellation fees may apply even if a confirmation text has not been received.</p>
